1. Application for registration of securities ownership transfer signed by the transferee.
2. The original share certificate(s) is/are endorsed by transferor and transferee.
3. A copy of the witness's identification document, certified true with an original signature.
4. Identification documents of the transferor, the transferee and the grantee (If any), according to the type of person. In case of other individuals, please contact SET Contact Center as shown at the bottom of the form.
5. Other type of securities transfer, please contact SET Contact Center as shown at the bottom of the form.

Individual Person - Thai Nationality	1. By Self-contact (The transferor <u>and</u> the transferee contact us personally) - The original of Thai National Identification Cards (Thai ID Cards) of the transferor <u>and</u> the transferee. 2. By Person authorized - The original of Thai ID Cards of the transferor <u>and</u> the transferee, as well as their certified true copies of Thai ID Cards. 3. By Registered mail 1) Certified true copies of Thai ID Cards of the transferor <u>and</u> the transferee and 2) The original of the document issued by the sub-district or district office, identifying to use those certified true copies instead of the original Thai ID Cards. A copy of the juristic person certificate issued by the Ministry of Commerce within the past 6 months, with the original signatures of directors authorized to represent the company or their representatives, following the company's conditions. 2. A copy of the national I.D. card/alien identity card/passport of directors who are authorized to represent the company, certified true with original signatures.
Juristic Person - Other Nationalities	1. A copy of the company's registration certificate issued by the regulating government agency. 2. A copy of the juristic person's affidavit of incorporation showing directors authorized to bind the company and conditions relating thereto, showing the company's headquarters location and authority of the signatory. This affidavit must be issued by an authorized official of the juristic person or the government agency having jurisdiction over the juristic person. 3. A copy of the passport or other official identity document of each authorized director signing this document, certified true with an original signature. <u>All documents for "Other Nationalities" above, must have been :</u> (1) The notary public or any competent authority in the country where such documents were prepared or certified correct, shall certify the signature of the person who prepared such documents, or who certified the accuracy of such documents. (2) An official of the Thai Embassy or Thai Consulate in the country where such documents were prepared or certified correct, shall certify the signature and the seal of the notary public or any other authority which performed the act under (1).
